




I, Michael G. McCarty, Registered Land Surveyor for Baudhuin Incorporated, do hereby certify that under the direction of Blue Sky Harbor Limited Partnership, we have surveyed the following described parcel:


A parcel of land located in Government Lots 1 & 2 of Section 21, Township 30 North, Range 28 East, Town of Baileys Harbor, Door County, Wisconsin, bounded and described as follows:

Commencing at the northeast corner of Lot 4 of C.S.M. No. 2758, as recorded at Vol. 16, Page 306 of Certified Survey Maps as Document No. 769585, said corner being on the centerline of Ridges Road, and the point of beginning of lands to be described; thence S. 02°31'01" E., 282.79 feet along said centerline to the intersection of said centerline and the centerline of Schmitz Road; thence S. 80°00'00" W., -- 370.17 feet along said centerline to the intersection of said centerline and the centerline of Harbor Lane; thence along said centerline of Harbor Lane as follows: 131.16 feet along the arc of a 270.00 foot radius curve to the left whose chord bears N.14°30'16" W., -- 129.88 feet (l < = 27°50'02"); thence N.28°25'18" W., -- 4.76 feet; thence 25.78 feet along the arc of a 34.00 foot radius curve to the left whose chord bears N.50°08'25" W., -- 25.16 feet (l < = 43°26'15"); thence N.71°51'32" W., -- 21.56 feet; thence 109.79 feet along the arc of a 91.00 foot radius curve to the right whose chord bears N.37°17'50" W., -- 103.25 feet (l < = 69°07'24"); thence N.02°44'08" W., - 11.34 feet; thence 18.63 feet along the arc of a 86.00 foot radius curve to the left whose chord bears N.08°56'26" W., -- 18.59 feet (l < = 12°24'37"); thence N.15°08'45" W., -- 7.28 feet; thence leaving said centerline, N.53°39'21" E., - 192.66 feet; thence S.67°10'54" E., -- 100.72 feet; thence N.89°59'08" E., -- 246.60 feet to the point of beginning.

Said parcel contains 140,188 square feet (3.22 acres) and is subject to the rights of the public over the easterly 30 feet and southerly 25 feet of said parcel for the rights of way of Ridges Road and Schmitz Road, respectively. Said parcel is also subject to all easements of record.

I further certify that the attached map is a true representation of said property and correctly shows the exterior boundaries and correct measurements thereof, and also shows structures thereon, and visible encroachments, if any.
